When: Saturday , May 18th @ 10am (registration at 9am)

Where: West End Regional Park, Chestnuthill Township located at 578 Evergreen Hollow Rd.

Directions: Rt 209 to Rt 715 in Brodheadsville. North on Rt 715 approximately 4 miles to veer left onto Evergreen Hollow Rd., then one mile to Regional Park.
